### MESSAGE FROM THE PRESIDENT



The 24<sup>th</sup> Annual Texas Jail Association Conference, held in Austin, Texas on May 10 – 14, 2010, was truly a success. We were astounded by the record breaking attendance, vendor support and membership. Our annual conference attendance increased from 515 to 559. At the 24<sup>th</sup> Annual Conference, TJA

issued 9,101 training hours to its members.

TJA has been setting new Association records every year. We are proving to our membership that we not only have a mission, we act to support our mission.

The Texas Jail Association developed our mission back on June 4, 1986. In this mission, TJA strives to accomplish

four goals. The first goal is to bring together those concerned with, or interested in, the professional operation and administration of jails in the state of Texas. We have proven this ideal by increasing our membership in the last year from 1,200 to over 1,400, which is a new record. This increase was only made possible due to a collaborative effort to actively recruit by the TJA Board members, current membership and the continued support from Sheriffs, Administrators and Counties throughout the state.

Our second goal is to advance professionalism through training, technical assistance, publications, peer interactions and conferences. TJA continues meeting this goal by providing training throughout the state. Not only do we offer training at two separate conferences, we also collaborate with the Correctional Management Institute of Texas (CMIT), Texas Commission on Jail Standards and the Texas

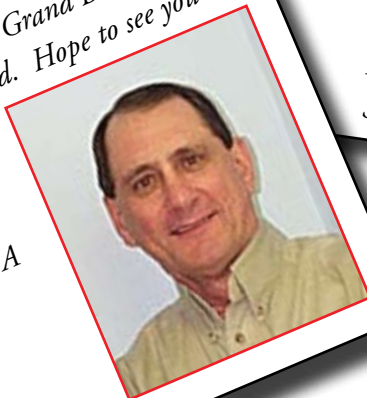

# Thank You Letters from Board Members



## BUYERS BEWARE

For those of you that have experienced the challenges of planning and building a new facility, I sympathize with you. For those of you who are in the planning stages, I caution you "BUYERS BEWARE." After a quarter century in law enforcement, I was finally going to be part of a new jail (something I had dreamed of, but was never able to accomplish).

Like many of you, I have had to deal with crowded conditions and antiquated equipment. Now I had the opportunity to put into play all the knowledge that I had accumulated during my tenure in law enforcement and County Corrections. Little did I know this would be one of the most challenging experiences of my life.

The planning process seemed to go quite well until our architect advised us he does not 'design by committee.' In essence, what he was telling us is that he would design the facility and we would have to live with his concept. This was our first red flag. We had been presented with three different designs ranging from 500 to 250 beds—big difference. Money, or the availability of funds, would be our only constraint. The Commissioners Court determined how much money would be available to fund the facility and your architect should design within those parameters.

Here are a few things to consider while building a new facility:

Advise your Commissioners Court to select an architect that has a good track record designing jails. Time spent researching your potential architect will pay off with big dividends. Develop a good dialogue with your architect and insist that your needs be met by the design of your new facility. You know what you need and your architect should have the knowledge to design a jail to meet those needs.

During the design phase of your new facility, **demand** that the architect provide you with any design changes, additions, or deletions. This consists of everything, no matter how trivial it may seem. It is much cheaper to make changes on a blue print than chip out concrete. Change orders are very expensive and can slowdown the progress of construction. Rely heavily on your jail standards and the Texas Commission on Jail Standards for guidance and direction. Provide your architect with the Jail Standards website; you would be amazed how much reinforcement it will provide you. Have your architect communicate

with the Jail Commission on a regular basis. The better the communication lines are, the quicker the plans will be approved.

The next phase is your general contractor; this is when it really gets serious. The general contractor will sublet every phase of the project. Ask the general contractor to provide you with a book that lists every subcontractor and what they are supplying for the jail. This makes for very good reading material and an education. Pay close attention to what your kitchen and restaurant supplier is planning for your kitchen. A consultant will design your kitchen and whoever gets the bid for the kitchen equipment will furnish it the way the consultant designed it. Beware of the \$35,550.00 coffee run! The sad part about the kitchen is you will probably never be consulted as to what you need until the bid has already been let out; but it is never too late to make equipment changes.

A word of caution, just because it is drawn on the print does not mean that it is included in the bid price. Furniture, built-ins, etc. need to be researched to find out if they are really part of the bid process, if not they will have to be purchased out of Furniture, Fixtures & Equipment or contingency funds (which can dry up in a hurry).

During the construction phase, it is recommended that you walk the facility daily. Anything that seems out of the ordinary probably is. Bring it to the attention of the general foreman and it will be addressed immediately. You should also provide the general foreman with the Jail Commission website so he can refer to it daily.

If your County hires a consultant, make sure he has the County's best interest at heart, otherwise he will draw a paycheck and you will rarely see him. If he has ties to the architect you are in trouble already!

As soon as you begin construction on your new facility, consult with the Jail Commission and request a staffing analysis. Make your Commissioners Court aware of the recommendations for staffing early on; therefore it is not as much of a shock when you have to hire additional staff.

## TRAINING REPORT

We geared up for the 24<sup>th</sup> Annual Conference in Austin and I think we hit every gear twice, and blew the doors off. Way to go everyone! We had another record breaking year with 559 participants. A huge thank you to 1<sup>st</sup> Vice President **Mike Starkey** and the training committee for a well planned conference. Of course, we cannot leave out **Sharese Hurst** and her crew for the outstanding job they do every year. The agenda for this conference was great and I fully expect the agenda for next year to be full of great topics.

We are getting ready for the Jail Management Issues Conference on South Padre Island, August 23-26, 2010. This year's conference agenda is set and online. We chose subjects suggested by our members and we have some really great instructors coming to the island; they include: Mark Warren, Nancy Baird, Jerry Garza and others. There will also be plenty of opportunities to sit around and network with your peers about any issue you may be having in your agency. I look forward to seeing everyone in August.

Over the past year, the Texas Jail Association has been busy assisting with training throughout the state. Our instructors do not get paid to travel around the state and provide training. At the May conference, I gave you some highlights of the numbers and I felt like it would be good to pass on the numbers to you again.

- Jail Management Issues Conference 2009, South Padre Island - 236 attended providing 4,720 training hours;
- Texas Commission on Jail Standards Basic 2009, 7 locations state wide - 327 in attendance with 2,616 hours of training;
- Jail Management and Operations for Chief Deputies, CMIT at Sam Houston State University - 48 attend granting 1,632 hours of training;
- Basic Jail Administrator Training, CMIT at Sam Houston State University / CMIT - hosted 2 classes with a total of 72 in attendance providing a total of 3,104 training hours;
- Texas Association of Counties Spring Regional training, 15 locations throughout the state - 812 attending classes giving 6,496 training hours; and,
- The 24<sup>th</sup> Annual Texas Jail Association Conference, Austin - 559 in attendance and 9,101 in training hours.

This gives your Association a total of 33,336 training hours from August of last year to date. The training committee is extremely proud of this accomplishment and plan on surpassing these numbers during the 2010/2011 training year. The TJA Board of Directors would like to thank all of our Sheriff's for allowing first off, the board members to work in this association and second, for allowing your jail staff to attend the training. We plan to exceed your expectations in training this year. If you have any question or comments please feel free to contact any training committee member or TJA board member. 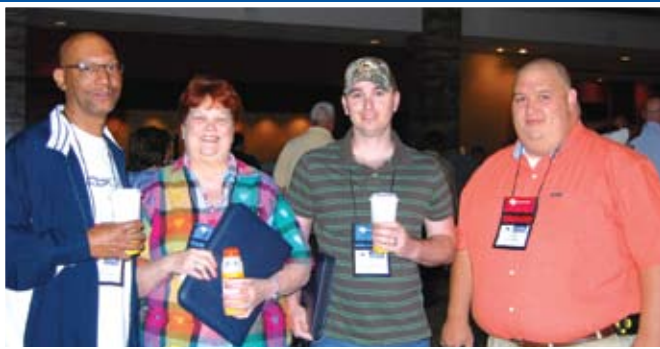

## WALKING THE WALK



Every morning by 7:30 a.m., Bastrop County Sheriff **Terry Pickering** is up and at the gym, or running outside.

“I come in and I spend 30-35 minutes doing cardio, sometimes on the elliptical machine. I try and change it up,” Pickering said. “After cardio, I work out with weights – maybe work on my biceps, or my back.”

His early morning workout has been a part of Pickering’s routine for so long that he has a hard time recalling when, or how, it began. It’s just habit.

Pickering, who joined the military after high school and then went straight into law enforcement, believes his background was a strong motivator to stay

in shape.

Pickering is hoping his “walk the walk” example helps motivate his fellow law enforcement officers and other Bastrop County employees to follow his healthy living example. But he doesn’t expect them to begin without help; instead, he took steps to prod them along their own paths toward wellness.

While running for the sheriff’s seat in 2008, Pickering heard a number of citizen complaints about the perceived lack of physical fitness among the area’s law enforcement officers. After reviewing his new department’s law enforcement claims information, Pickering had hard evidence that something needed to change.

Pickering decided to institute physical standards for all Bastrop County sheriff recruits. Now, to become a deputy in Bastrop County, recruits have to successfully complete a physical fitness test that includes a timed 1.5-mile run and a 300-meter sprint, complete a certain number of sit-ups and push-ups and hit a certain height doing a vertical jump.

Current law enforcement employees are not exempt. In 2011, current employees will be asked to pass the physical test. Pickering wants employees to use the rest of 2010 to get in shape and be ready for more rigorous physical standards.

“We already made these standards known,” Pickering said. “I believe we must do whatever we can to make sure we provide them the ability to meet these standards.”

So Pickering put his money where his mouth was, and within a year had found funding within his department’s budget for the new county gym facility. The funds came from the inmate phone fund.

It’s this dedication and drive that many of Pickering’s colleagues admire.

“After we first started talking about doing the gym, we realized we could not fund it through the county’s budget. There just was no room,” Bastrop HR Director and Healthy County Coordinator **Charlotte Collins** said. “But, the Sheriff was bound and determined to get it done. So he picked it up, took off, and did it on his own.”

“What he advocates for is common sense, but what he does - it’s not common,” she added.

The Texas Commission on Jail Standards held the inaugural Courtroom Challenge Tournament at the Annual Jail Management Conference held at Sam Houston State University in Huntsville, Texas in October of 2000. Due to its success, the tournament was moved to the Texas Jail Association Spring Conference after the first year. TCJS would also like to thank Lt. **Mark White** and Training Officer **Bud Sansberry** from the Williamson County Sheriff's Office for developing the Courtroom Challenge game and for sharing the concept with us. Your idea and forethought has increased the knowledge of minimum jail standards for many, many people across the State of Texas. And for that, we sincerely thank you for your efforts...

In the early years, the competition had anywhere from 7 to 10 teams participating in the double elimination tournament. The popularity of the tournament continues to grow and with it, the number of teams participating continues to grow as well. ## PRESIDENTIAL LEADERSHIP QUALITIES

Review of *The Leadership of George Bush: An Insider's View of the Forty-First President*, by Roman Popadiuk, Texas A&M University Press, College Station, Texas, 2009, pp. 227 (hardcover).

Rarely does a day go by that a new book is not published on the subject of leadership, and persons interested in learning more about this subject frequently experience difficulty in ferreting out the wheat from the chaff. A relatively new book is now available that is instructive on the subject of leadership, drawing examples from former President George H. W. Bush.

George H. W. Bush, who served honorably as the 41<sup>st</sup> President of the United States, devoted his life to public service. In *The Leadership of George Bush: An Insider's View of the Forty-First President*, Roman Popadiuk, Executive Director of the George Bush Presidential Library Foundation, examines the leadership qualities of the former President and how they served him and this country during his exemplary career.

Popadiuk, like the subject of his book, has an impressive résumé in public service. He joined the U. S. Foreign Service in 1981, a year after earning a doctorate from the City University of New York. From 1982 to 1984, he served in Mexico City, where he performed consular and political work and was special assistant to the Ambassador. From 1984 to 1986, he served a tour of duty with the Department of State and the National Security Council. In President Ronald Reagan's administration, Popadiuk served as an Assistant Press Secretary from July 1986 until March 1988, when he became Special Assistant to the President and Deputy Press Secretary for Foreign Affairs. In October of that year, the President appointed him a Deputy Assistant. In January 1989, newly elected President George H. W. Bush appointed Popadiuk to be Deputy Assistant to the President and Deputy Press Secretary for Foreign Affairs. He served as the first U. S. Ambassador to independent Ukraine from 1992 to 1993. From 1993 to 1995 Popadiuk was on the faculty of the State Department's Foreign Service Institute. In August 1995 he assumed the duties of International Affairs Advisor and senior civilian on the staff of the Commandant of the Industrial College of the Armed Forces at Fort McNair, a position he held through the summer of 1998. Commencing in January 1999, he began his service as Executive Director of the George Bush Presidential Library Foundation.

In *The Leadership of George Bush*, the author has produced an insightful and easily read book, in which he identifies Bush's leadership qualities and how they shaped his decision-making process and the manner in which he conducted himself.

After providing a very brief biography of Bush in the first chapter, Popadiuk reveals and discusses the four values that influenced his character – faith, family, friends, and commitment to service.

In chapter 2, the author presents the former President's "Rules of Behavior," which are as follows:

1. Don't get down when your life takes a bad turn. Out of adversity comes challenge and often success.
2. Don't blame others for your setbacks.
3. When things go well, always give credit to others.
4. Don't talk all the time. Listen to your friends and mentors and learn from them.
5. Don't brag about yourself. Let others point out your virtues, your strong points.
6. Give someone else a hand. When a friend is hurting, show that you care.
7. Nobody likes an overbearing big shot.
8. As you succeed, be kind to people.
9. Don't be afraid to shed a tear when your heart is broken because a friend is hurting.  
Say your prayers!



These “Rules of Behavior” are followed by Bush’s “Rules of Management” as identified by Popadiuk; they are as follows:

Standing up for your beliefs;  
 Telling the unvarnished truth;  
 Loyalty;  
 Expecting mistakes and admitting your own;  
 Communication;  
 Giving credit to others;  
 Showing your human side;  
 Realizing that all actions have consequences; and  
 Ensuring that everyone has a role and knows what it is.

In the remaining seven chapters the author amplifies on Bush’s character and “rules” and weaves them into how he organized the White House and how they impacted his governance style. Moreover, discussion is devoted to communications and media relations, the world of diplomacy, Bush’s relationship with Congress, managing the economy, and the campaign of 1992.

Whether or not one agrees with his politics, it cannot be denied that George H. W. Bush was an honorable man who devoted his life to public service, and that by studying his personal traits and beliefs can be instructive. Persons interested in learning more about leadership – regardless of their position in an organization, be it a Fortune 500 CEO or a shift supervisor in a county jail – will find *The Leadership of George Bush* a rewarding read.

With this book, Roman Popadiuk has made a significant contribution to the study of political science and leadership.

When the Lubbock County Sheriff’s Office announced efforts to recruit new members and re-new existing memberships for the Texas Jail Association, they decided to



create the “Legacy Award” in honor of Major **Jerry Baggs**, who was instrumental in founding the Texas Jail Association and served as its first President.

Supervisors from A, B, C Shift and Logistics set out to achieve the goal of 50 new members. Weekly updates were put out to the staff. In no time, the first goal of 50 new members was achieved. The goal was then increased to 100, then 150 and finally 200 new members. Supervisors began developing strategies to encourage their staff to join TJA and the competition was on!

Different ideas came forth, but the first spawned from one officer who renewed his membership and donated another \$20 dollars to sponsor two of his co-workers, all he requested was he remain anonymous, thanks Mike! This ignited many of the officers who joined to voluntarily sponsor a fellow officer. Raffles and bake sales were held by some shifts. One shift raffled off a shotgun and a gift certificate. Another raffled off chances at a TJA membership, handgun ammunition and a pie throwing contest. Chief **Danny Downes** and Assistant



Chief **Kim Howell** willingly agreed to take a pie in the face if the shift could raise \$200 for the Chief and \$150 for the Assistant Chief. The shift was able to raise the money within 20 minutes and help fund another 11 memberships! Following in those footsteps, other supervisors agreed to sell tickets to receive a pie in the face as well. The A shift Watch Commander originally agreed to dress up as a clown in order to raise money for new memberships. However, when he realized that tactic was not as successful as the pies in the face, he agreed to take 10 pies in the face for the first 10 people who joined or sponsored other staff members. Two Sergeants, one from B shift and one from Logistics, wagered the Sergeant who could not reach the 100% membership goal within their area would have to wear a dress to briefing. News of this bet fueled the competition even more and the memberships continued pouring in.

At the end of the competition, and once the dust settled, A shift reached 81% membership, B shift reached

### DALLAS COUNTY

**Large Water Main Break Disrupts Dallas County Offices and the Sheriff's Department for Nearly a Week**



A large water main break flooded the basement of the Records building in downtown Dallas on the evening of May 31st. Unfortunately, that's the building that houses the hardware and switches for all county computers. The water level reached at least 6 feet high bringing all computer and online systems such as AIS (Adult Identification System) to a halt. All county email and blackberry systems were put out of commission as well.



Sheriff **Lupe Valdez** immediately set up a 24/7 command post to keep the lines of communication flowing in the jail and to initiate the process of doing work the old fashioned way, by hand. All processing of inmates for the intake and release sections were hand written with plans to input the information into computers once the systems came back online. All offices resorted to using fax machines, runners, radios and telephones for every day communication.

The command post helped all areas of the sheriff's department to operate as efficiently as possible including Parkland Memorial Hospital (which operates inside the jail), judges and the court system as well as other departments outside the sheriff's dept. All areas continued to run smoothly for most of the week until the water could be bailed out and a generator could be brought in to get the department back online and fully operational. By Friday morning regular email, AIS, and OMNIXX (which provides data from TCIC and NCIC files to do background and criminal history checks) were back online.

Sheriff Valdez said, "I couldn't be more pleased with my entire staff. This recent crisis is a true test of how well our department pulls together during a crisis. We not only "managed," but we rose above the crisis to meet every challenge head on. Our success is a testament to the "grit" and "can do" spirit of everyone working at the Dallas County Sheriff's Department."

The computer systems are working again and any new glitches are being handled immediately. A request was made previously for back up generators for just such a crisis and hopefully we will not have a repeat of this kind in the near future. Of course, if it does happen, our staff is well equipped and more than prepared to handle it.

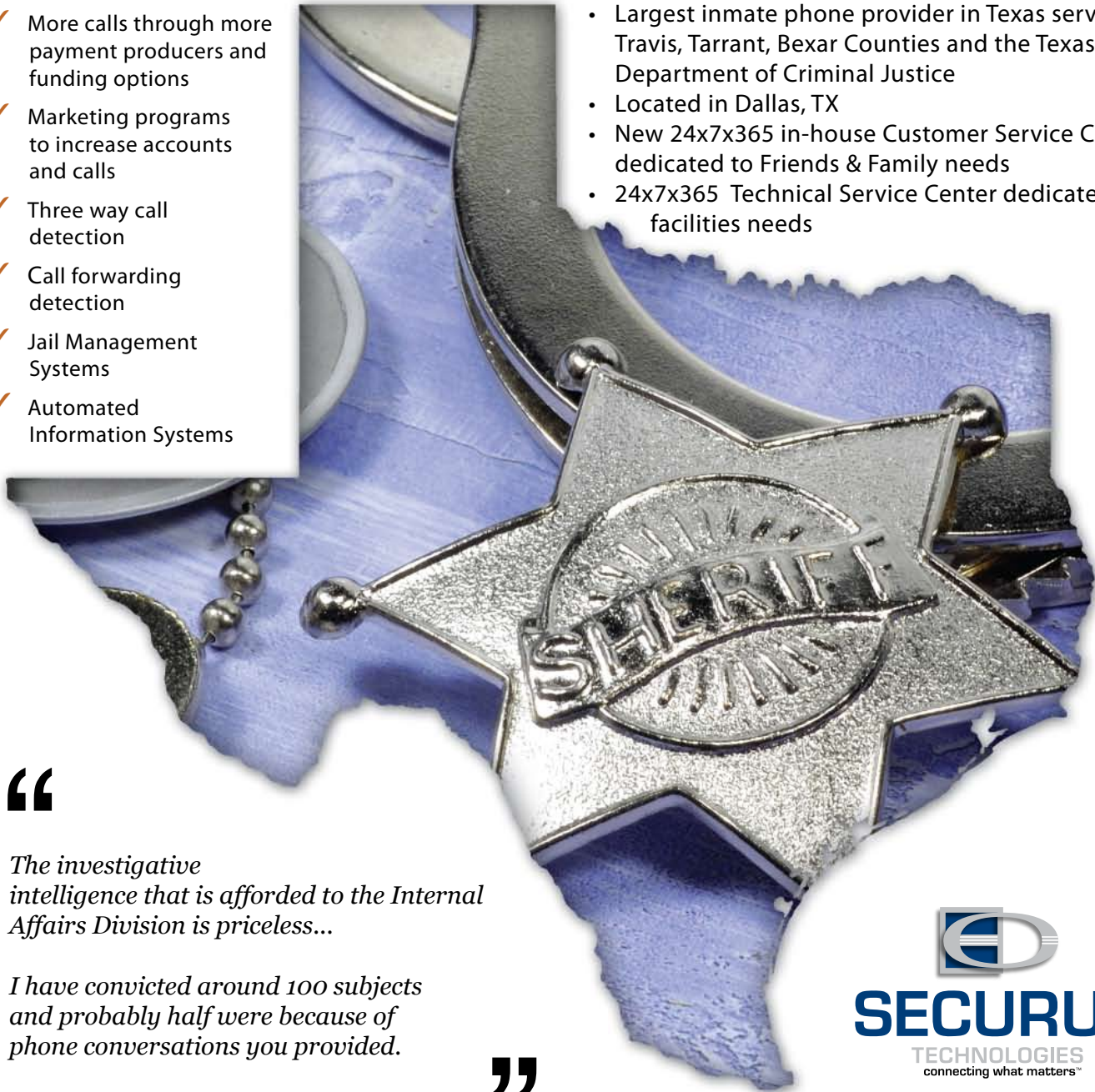

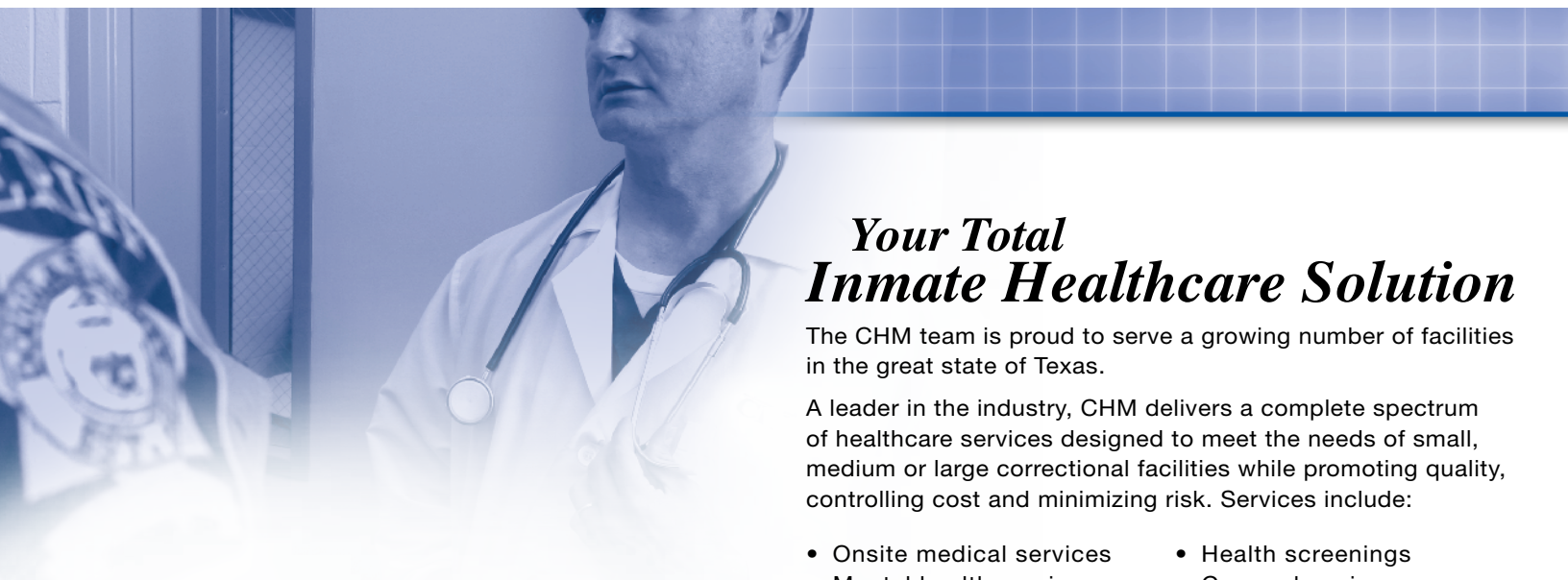
