This is a very exciting time to be a member of the Texas Jail Association as we venture into the future, fulfilling the mission of our Past Presidents. As our mission statement guides the direction of the Association, your Board bases its decisions on that vision.

**To bring together those concerned with or interested in the professional operation and administration of jails in the state of Texas;**

**To advance professionalism through training, technical assistance, publications, peer interactions, and conferences;**

**To provide leadership in the development of professional standards, management practices, programs, and services; and,**

**To advance the interests, needs, and concerns of the membership.**

I am pleased to announce the arrival of a new member benefit. The Association has entered an agreement with Texas A&M Engineering Extension Service to provide a TJA member an

“etoken” that can be redeemed for one of eleven selected classes. The “etoken” will be valid for 6 months after the date of issuance. A member can receive one “etoken” annually at no cost to them for the course. Now, a member can get that one class they may need to advance their license or if carrying a dual license they can take a class that will go towards the 40 hour training cycle. This benefit will apply to lifetime members, new members, in addition to those current members that renew their membership. Third Vice-President and Membership Committee Chairman, **Todd Allen** has written an article giving you more information as well as the list of classes offered. I just couldn't keep something this exciting a secret, and I encourage you not to either. Tell a friend, tell a stranger, and tell EVERYONE why it is so awesome to be a TJA member!

David founded Outreach for America in 1988. # CMIT Focuses on Mental Health Issues in Criminal Justice

More than 300 people attended the inaugural Mental Health Conference offered by the Correctional Management Institute of Texas (CMIT), where counties and professionals presented and discussed best practices in serving the mental health needs of offenders in the various components of our criminal justice system.

“It starts with intake by the officer on the street and goes all the way through the criminal justice system until they reach the end of their probation and or parole,”

enforcement, advocacy groups and medical professionals. It featured initiatives implemented in many counties in the state as well as professionals in the field.



said Carmella Jones, program specialist for CMIT. “The process is a challenge for all offenders, but for those with mental health issues, there are so many more needs for services. All the counties are facing the issue, but some are more amplified than others. We realize it takes all of us working together to deal with these issues.”

The conference featured a series of workshops that



addressed mental health issues throughout the system, including corrections, parole, probation, courts, law

“It was valuable to work with numerous people from all walks of the criminal justice system,” said one participant.

To address the needs of people with mental health issues in the criminal justice system, the four-day conference offered sessions on assessing offenders for suicide, medical and mental health issues; implementing effective mental health services in jails; understanding criminal and civil competency issues in courts; addressing the needs of veterans and other special populations with substance abuse or medical issues; establishing mobile



crisis intervention services; focusing on medication issues; exploring legislative mandates; and collaborating with other agencies.

“I found the speakers and their knowledge of the topics to be very beneficial,” said another participant. “They were all very open to answering questions as well as providing contact information for future questions.”

Counties shared programs they have implemented to address the needs of offenders with mental health issues. Among these are:

- Rockwall County, the smallest county in the state, provides direct behavioral health service to identified inmates.
- The University Health System in San Antonio developed a diversion program for people arrested by the city magistrate to prevent incarceration of persons with special needs, and offers assessment, crisis intervention, brief counseling and community referrals for those in the program.
- Montgomery County offers an inpatient competency restoration program through a collaborative effort between the county jail and the Texas forensic hospitals.
- The Travis County Sheriff’s Office established a mental health team to respond to calls for people in crisis and to divert them to mental health services.
- The Lubbock County Sheriff’s Office implemented special therapeutic housing units in its jail and conducts in-jail restoration of competence to stand trial.
- MHMR of Tarrant County has developed programs to deal with people with mental illness who come in contact with the criminal justice system, from prearrest through sentencing.
- The Harris County Office of Mental Health and Medical Security Unit, which was awarded the 2013 Program of the Year by the National Commission on Correctional Health Care, provides specially trained sheriff’s deputies assigned exclusively to the unit, where inmates receive mental health and general health care.

- Bell County’s Community Supervision and Corrections Department, which developed a PTSD/Substance Abuse Program and Veteran Court to address issues involving the unique needs of this population.
- Brazos County Mental Health Unit provides a crisis intervention team and diversion program for offenders with mental health issues.
- The Burke Center provides a variety of quality behavioral healthcare services to people with mental health and intellectual and development disabilities for 12 rural counties.

“Having the opportunity to hear what other mental health centers are doing and the way they collaborate with the various community agencies in their area was the most beneficial,” said a third participant.



The sessions also discussed upcoming legislative changes, including the Mental Health Standards by the National Commission on Correctional Health Care, which outlines benchmarks for care and treatment, administration, personnel and legal issues

One of the key messages from the conference was the need to work collaboratively with partners in the community. “There is strength in numbers,” said Lee Johnson, Deputy Director of the Texas Council of Community Centers. “Strong partnership can have a tremendous impact on public policy decisions.”

# CALL FOR NOMINATIONS

Election time is coming and we need good people from around the state to continue the tradition of dedication and commitment set by current and past officers and board members. Become involved; submit a nomination now. The Nomination Committee of the TJA will be selecting a slate of candidates for the following positions:

## **THIRD VICE PRESIDENT**

The person elected will serve progressively through the vice presidential chairs to become your president. Give some serious thought to this nomination and present yourself, or someone else, to the Nomination Committee. The eligibility for this elected office is contingent upon active “**professional**” membership in good standing with the Association for a period of one year prior to election. The member must have served at least one year on the Board of Directors in order to be eligible for this position. The member elected will be required to attend approximately four meetings per year.

## **BOARD OF DIRECTORS – Two Positions Available**

The Board of Directors shall be the governing body of the Association. The President shall be the presiding officer at all board meetings. The Board shall be empowered to authorize expenditures for the general business of the Association, authorize additional expenditures, and set appropriate charges. The Board may enter into any agreement or contract with other personnel or organizations for the advancement of the Association. Eligibility for this elected office is contingent upon active “**professional**” membership in good standing with the Association for a period of one year prior to election. Members elected to this position shall serve a three year term in office.

## **NOMINATION PROCESS**

Nominations with an attached resume, picture, and letter of endorsement from the agency head are to be returned to **TJA Headquarters, Attention: Sharese Hurst, Box 2296, Huntsville, Texas 77341-2296**. All packets will be sent to the Nomination Committee Chair for verification of eligibility and distribution to committee members.

## **Guidelines for nominations**

1. Individuals must be **professional** members in good standing as specified in the by-laws at the time of nomination.
2. Nominating Committee members shall not be considered for office.
3. Only hard copies of nominations will be considered. Self-nominations are acceptable.

4. Office being sought shall be identified in the nomination.
5. Endorsement of the affected agency head must accompany the nomination. Nominations lacking the agency head’s endorsement will not be considered for office.
6. Elections shall be conducted in accordance with the provisions of Article VI of the by-laws.

**Nominations must be received by **March 10, 2015**.** All nominations shall contain the following for consideration: **Full Name, Current Occupation, Official Title, Business Address and Phone Number, a brief biographical sketch (not to exceed 50 words), letter of endorsement from the agency head, and a picture to be included on the ballot.** Nominations received after the deadline cannot be considered.

### CHINESE DELEGATION VISITS EL PASO COUNTY SHERIFF'S OFFICE FOR BEST PRACTICES

On November 5, 2014, the El Paso County Sheriff's Office hosted a visiting group from the Public Security Department of Yunnan Province, China.

Yunnan Province shares 2,520 miles of borders with Myanmar, Laos and Vietnam. To combat ever increasing smuggling, drug trafficking and cross-border crimes, a 25-member delegation began a 21-day training programming in the United States of America.



The EPCSO provided information on the responsibilities and mission of the Sheriff's Office and the role of the Sheriff. The close

collaboration of the El Paso law enforcement community was emphasized and a tour of the El Paso County Detention System Jail Annex facility was provided to showcase security aspects that aide in maintaining El Paso's designation of being the safest city.



### EL PASO COUNTY DETENTION SYSTEM EXPANSION HITS PHASE 2

The El Paso County Detention System has begun Phase 2 of the Jail Annex Facility expansion. Phase 1 included increasing support services areas such as laundry, kitchen, and property storage. Because



of demographic change in El Paso County, an Initial Intake and Booking Area featuring an open seating design was added to the facility. The decentralized booking option has allowed for a quicker return to the field for arresting officers.



Phase two of the expansion will provide an increase of 442 beds which includes 10 infirmary and 96 single cell of which 12 are suicide prevention cells. The pods are designed with 2 multi-purpose rooms and each pod has a counseling or exam room. Each also has a violent separation cell. With an expected completion date of July 2016, the new addition will allow further efficiency in supervision and provide cost saving medical care options.

### SHERIFF WILES ADVOCATES FOR COMMUNITY MENTAL HEALTH RESOURCES

As the legislative sessions near, Sheriff Richard Wiles and his staff continue their mental health advocacy through membership in groups such as the University of Texas at El Paso Brain Trust, participating in the El Paso Sequential Intercept Mapping, and by serving as speakers at events like the Behavioral Health Legislative Symposium and the Texas State of Mind Tour. Staff members



have visited an array of facilities providing mental health services both to inmates and the general public. 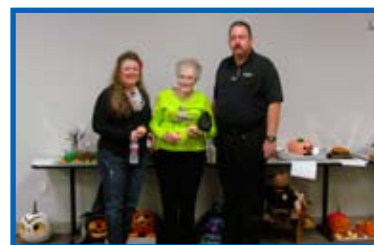

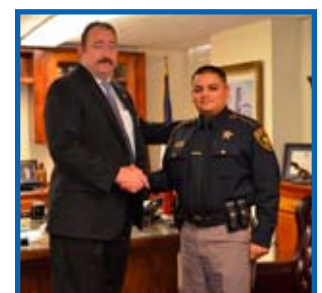
The Lubbock County Sheriff's Office participated in the South Plains Career Expo.
